Notice of Partial Amendments to the Articles of Incorporation

The Board of Directors of Bell-Park Co., Ltd. approved a resolution today to submit a proposal for Partial Amendments to the Articles of Incorporation at the 30th Annual General Meeting of Shareholders to be held on March 23, 2023.

1. Reasons for amendments

Bell-Park is proposing amendments to the current Article 24 (Directors with Specific Titles) and Article 25 (Representative Director) because there may be more than one representative director at some point in the future. Shareholders will also be asked to approve amendments to the current Article 14 (Convener and Chairman) and Article 21 (Convener and Chairman of the Board of Directors). These amendments will create a framework for the Board of Directors to establish in advance the method for the determination of the directors for convening and chairing shareholders meetings and meetings of the Board of Directors when there is more than one representative director.
